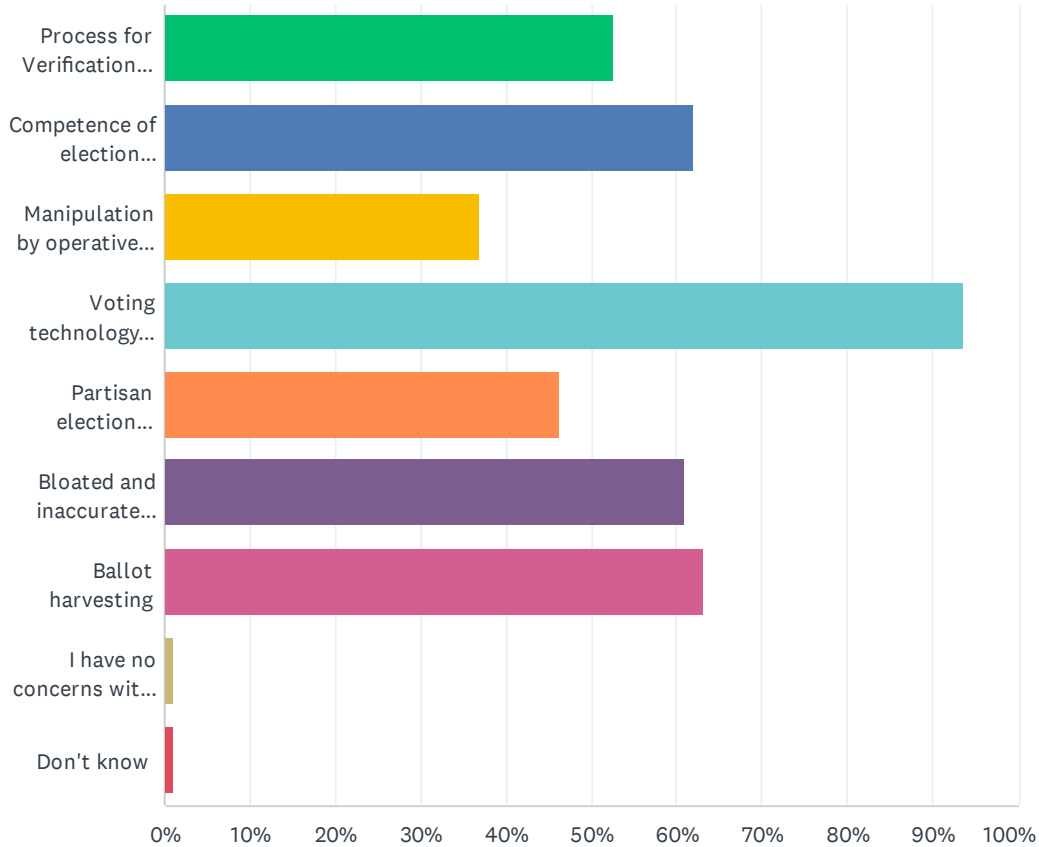

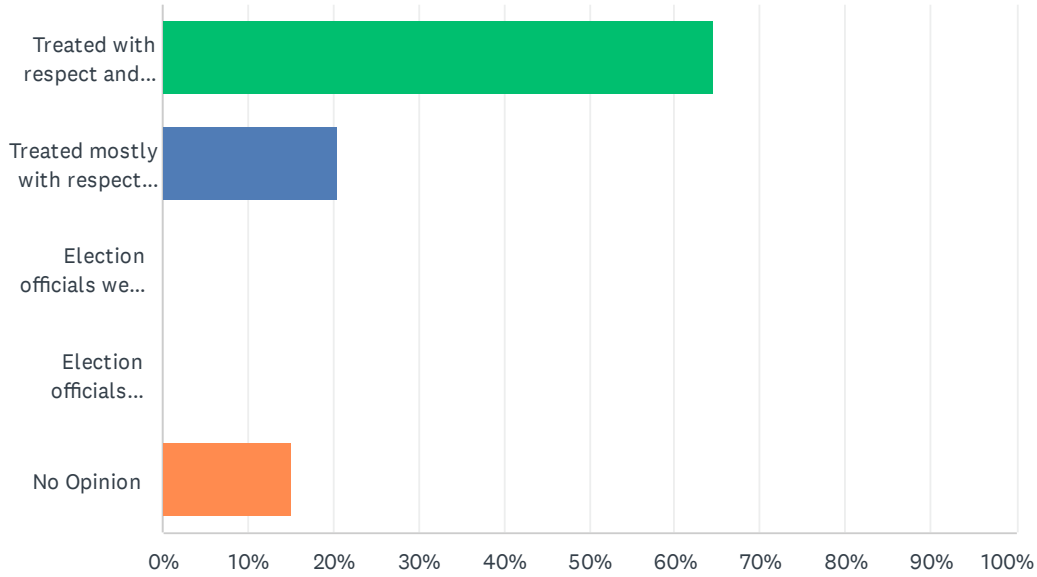

### Q9 What level of access did you experience with regard to observing the voting process in your shifts as an observer / poll watcher / inspector or challenger?

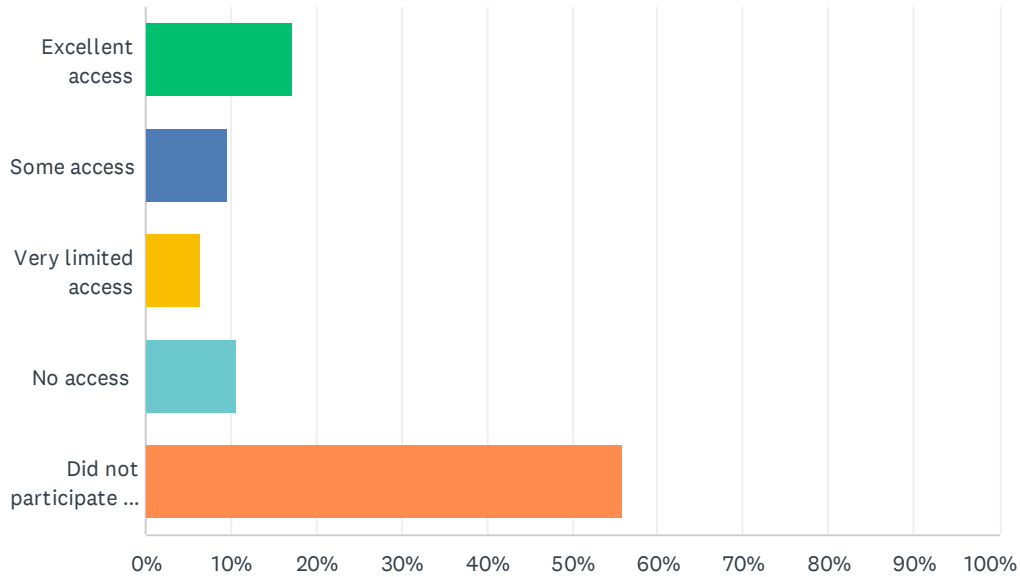

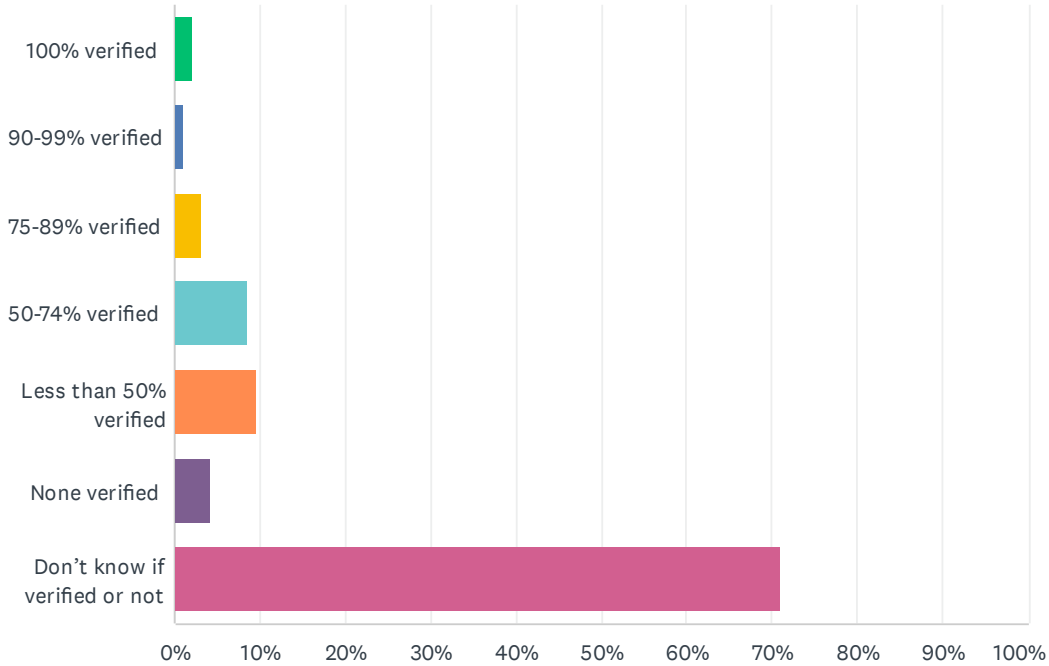

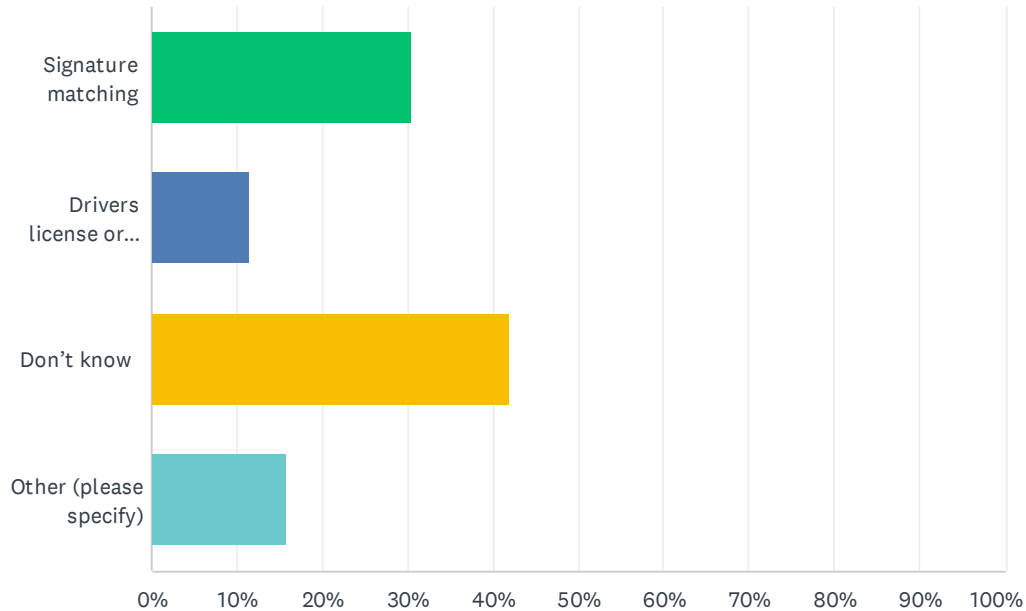

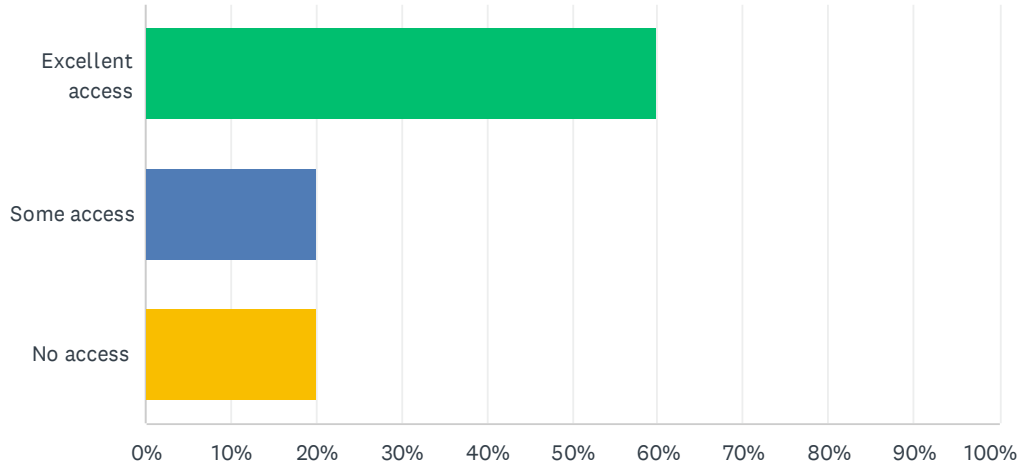

### Q14 What level of observation did you experience during logic and accuracy testing of voting equipment?

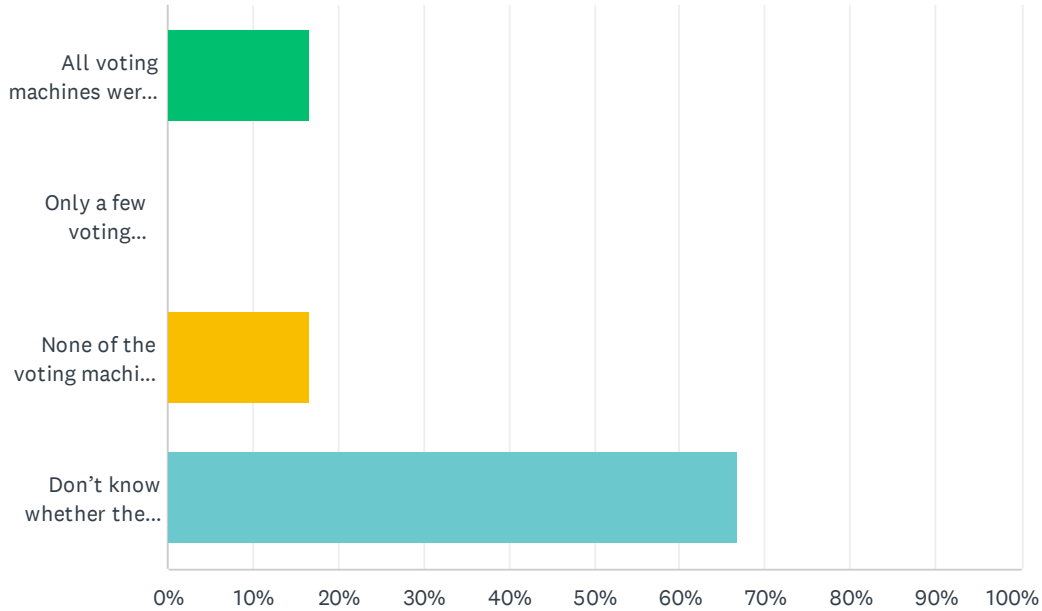

## Q15 What percentage of the voting machines were tested during the logic and accuracy testing in your county?

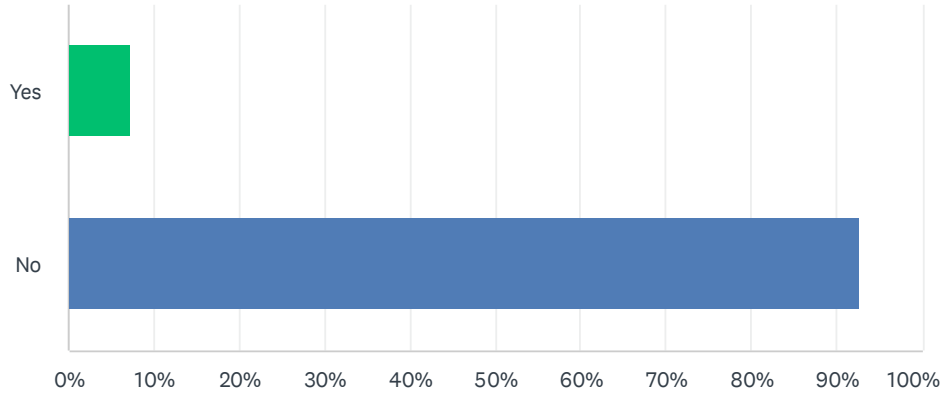

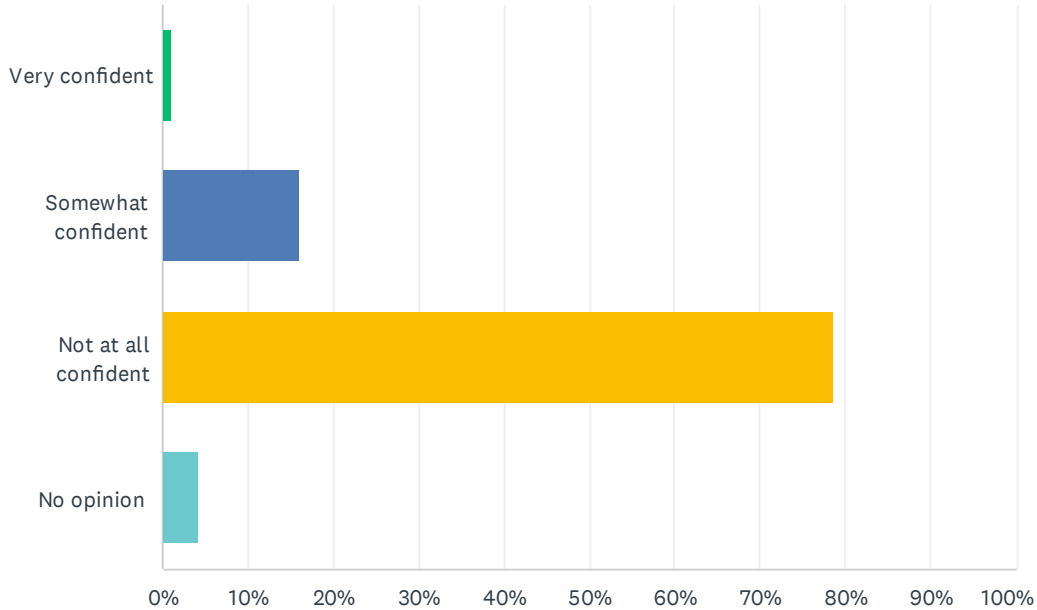

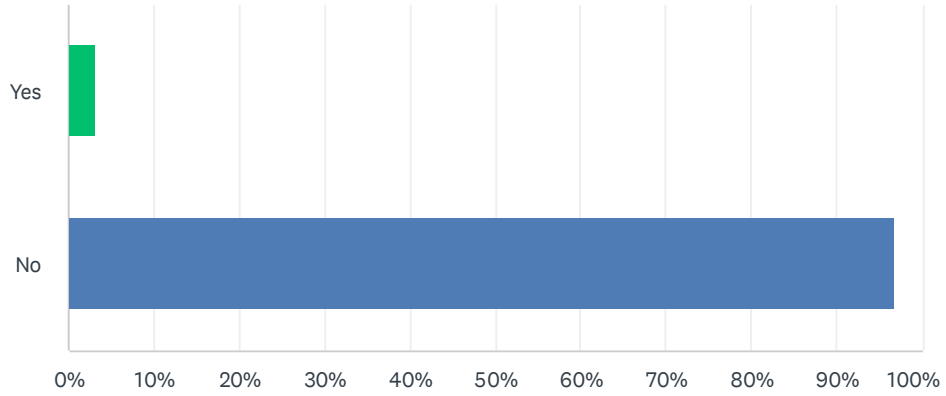

### Q19 Were you involved at any time in the processing or review of overseas military and civilian ballots / voting, or observing that process?

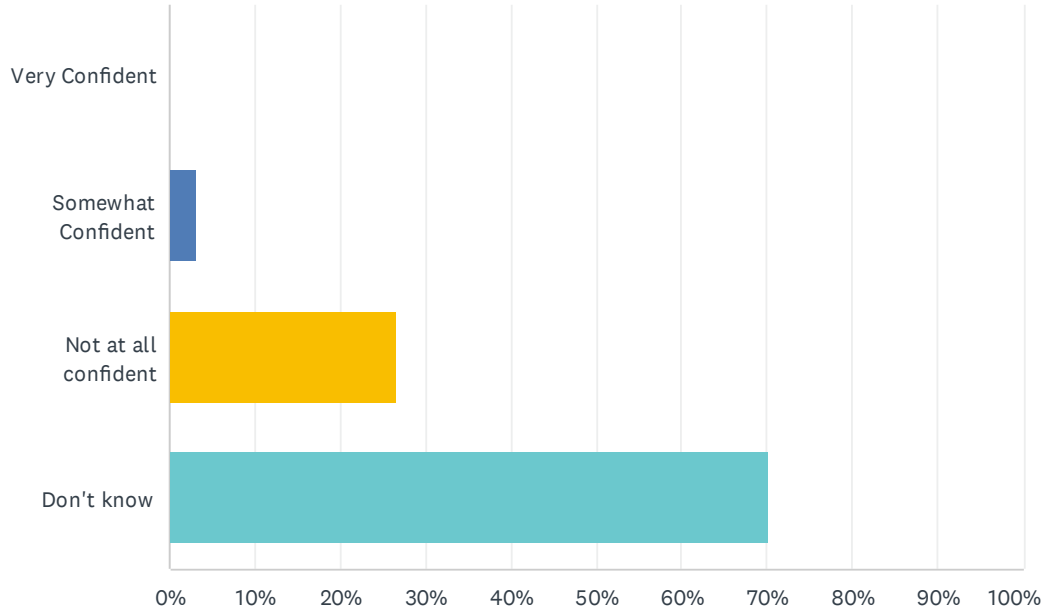

## Q20 How confident are you that the identity and eligibility of overseas voters were confirmed prior to their ballot being forwarded or counted?

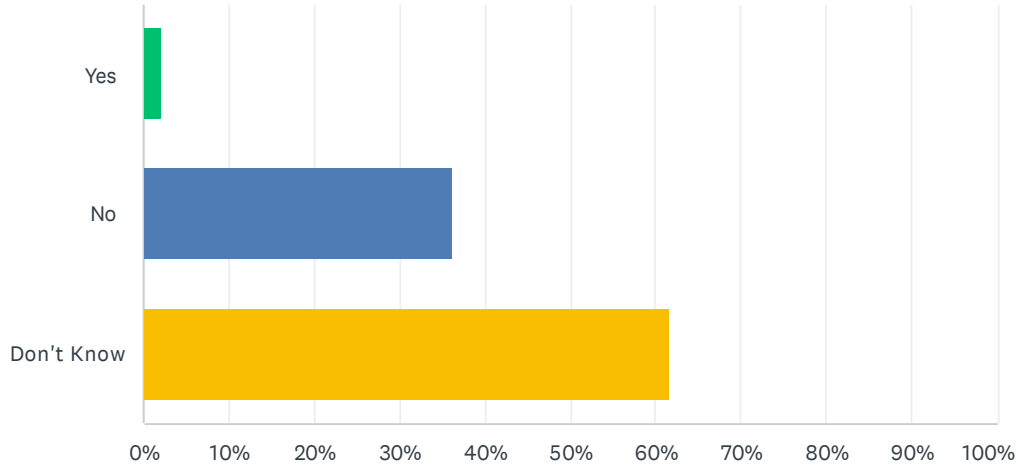

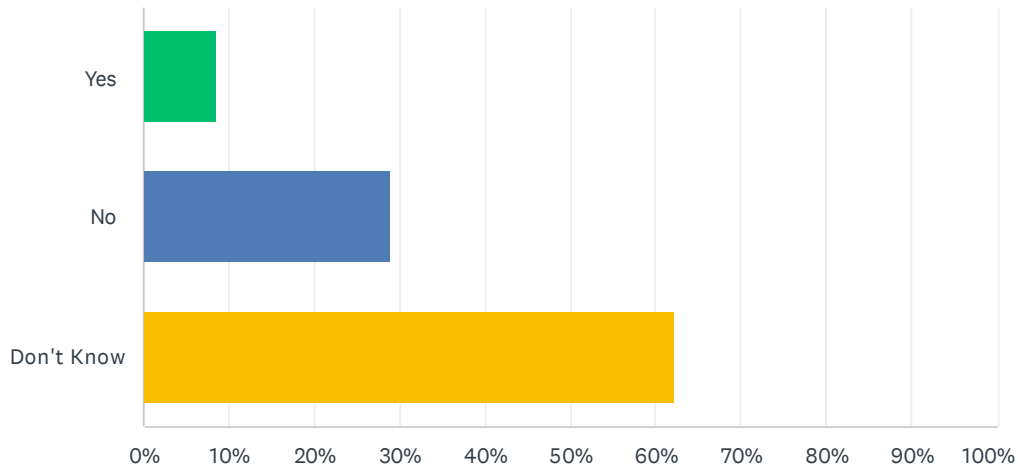

## Q22 Was your poll watching system in your location set up to allow observers to confirm that the number of votes on the machines each morning matched the number of votes the night before?

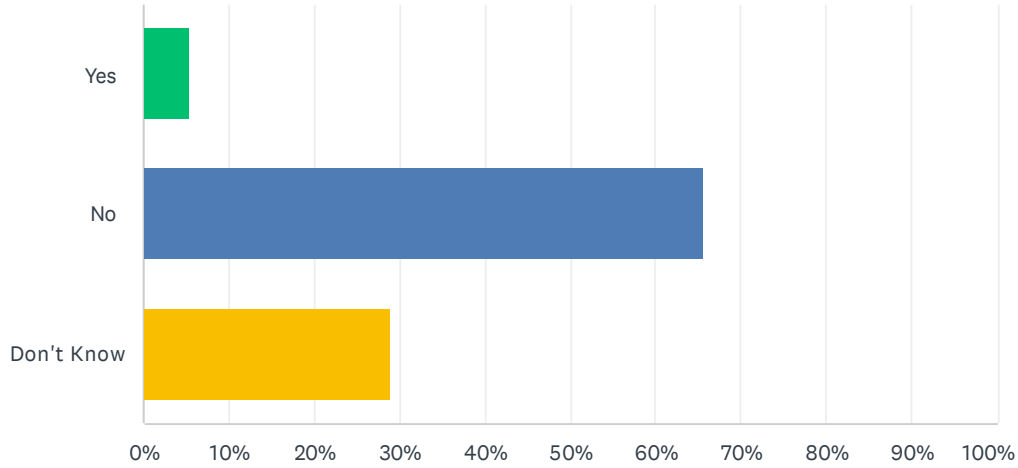

### Q23 Were you able to observe whether the number of votes each day matched the number of voters who signed in and were recorded as having voted that day (or, cumulatively for that location)?

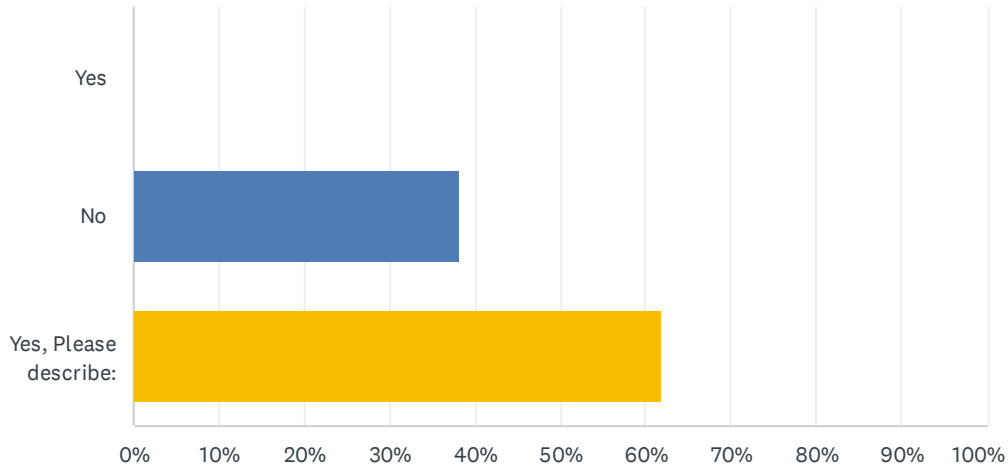

4	I was a closing poll observer. Upon arrival, I was told one tabulator was not working since 11am. I stepped outside the 75' and called Gina. Her voice mail was full, so I sent a txt. The other tabulator was questionable in that it seemed fragile in accepting votes. Also, I watched a woman, who was part of the crew working there, walk out with a black bag but have no idea if it was personal items or not. I will say, though, that I did NOT see where the drop off ballots went. The end of the night was a bit of a mess. The supervisor had to call some technician because of some malfunctioning problem with both tabulators. I wasn't privy to that conversation but could hear them talking. They had to restart the computers on the tabulator more than once. I DID already get the numbers off the tabulators, which I forwarded to Gina and Bree. Along with a summation of what I observed and thought I observed. I tried to get a count off the sign in computers (whatever they are called) as per Gina's instructions, but no one had any idea how to get them. Including someone that was considered to be a tech guy there. There were about 8 to 10 sign in computers. They all seemed to function fine because I didn't see any issues arise. Someone made a decision to change the 2 black bags (one for each tabulator). Because of an abundance of C slot votes on each tabulator, they put all of	11/16/2022 6:19 PM

them from both tabulators in one black bag and all the submitted and tabulator accepted votes in the other black bag. That's what I was told, anyway. They also used some plastic baskets for the spoiled ballots. This is my first time doing this, but it sure seemed a little disorganized. Understanding, of course, this isn't anyone's full time job and a lot of us were first timers. If I had a better idea how messed up the end of the night was going to be, I would have tried to get even better notes and observances that I did. btw, I did see the Supervisor take some kind of computer chip (?) out of the tabulators, as directed by the person on the other end of the phone. She had to do that a couple time, AT LEAST, before they could complete whatever it is they were trying to get to on the tabulators. The staff was, mostly, very nice and I think did what they could. But something didn't feel right. I don't know how a voting system that depends thoroughly on tabulators doesn't have them in PERFECT working order before they arrive to a polling place. The biggest and most important pieces of the voting puzzle and they worked as well as an old car with no tires. Outrageous.

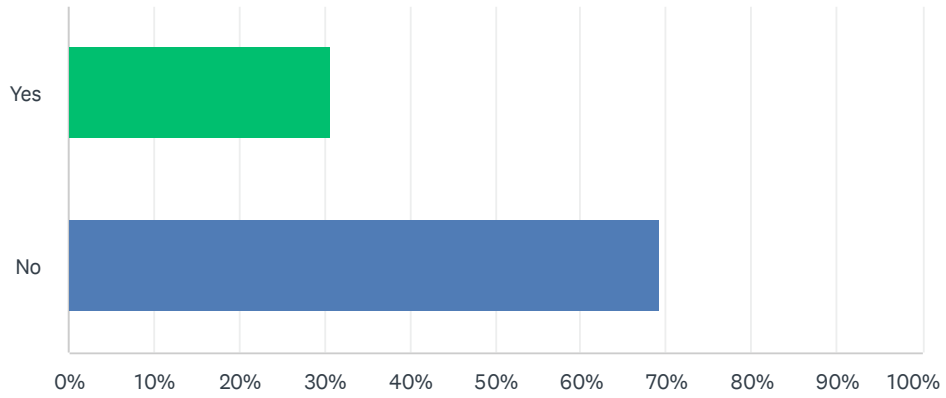

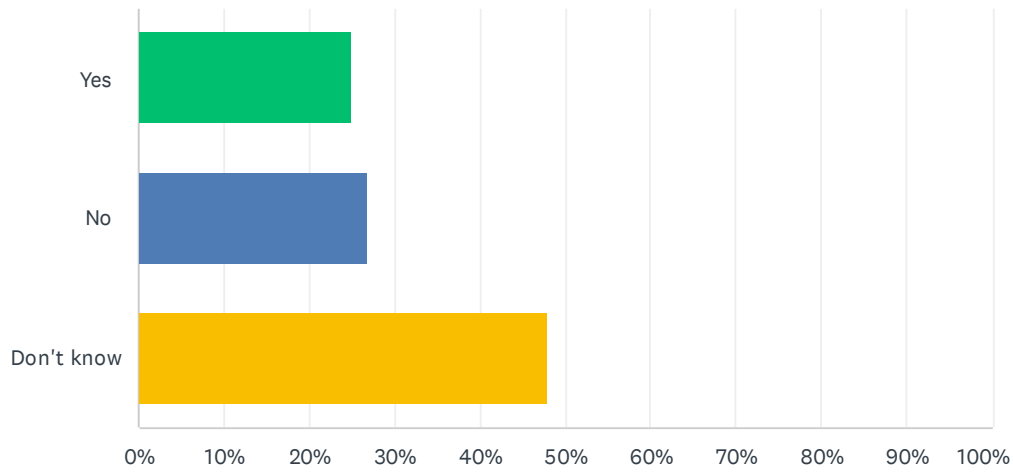

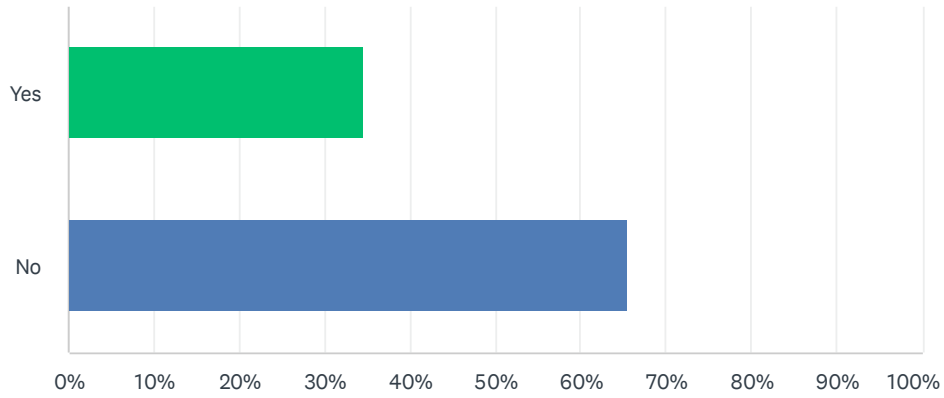

### Q27 Did anyone get back to you regarding the issue, incident, or problem that you reported?

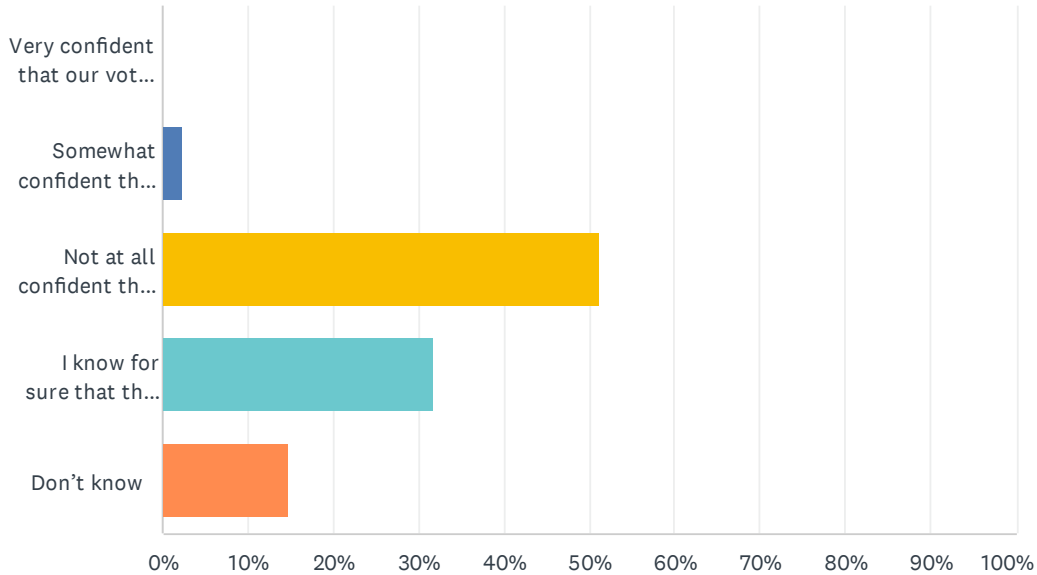

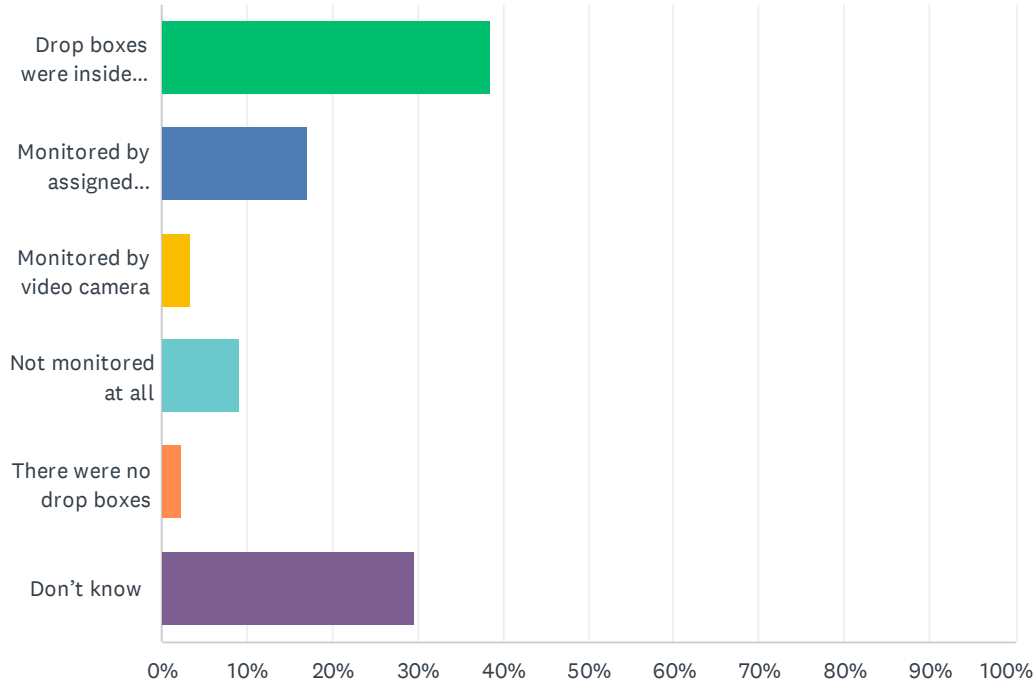

## Q29 Were ballot drop boxes monitored and, if so, how were they monitored?

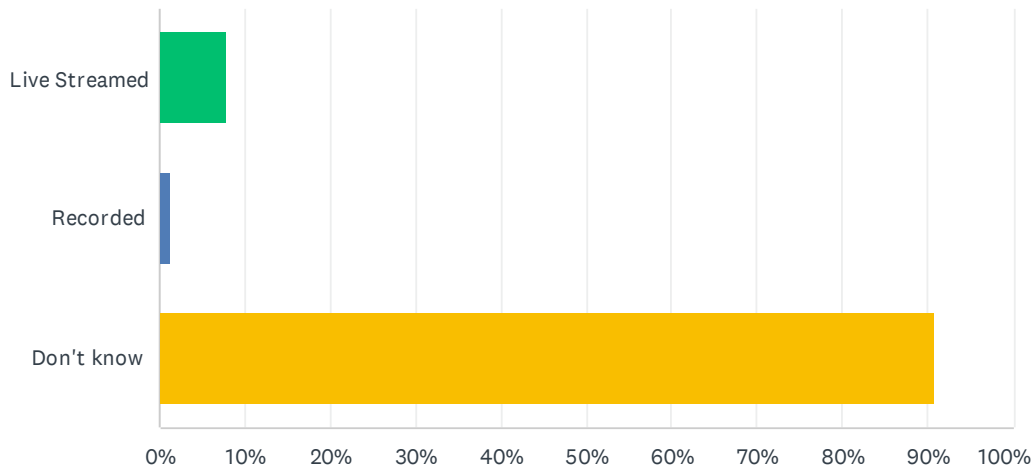

### Q30 If monitored by video camera, was it live streamed or recorded?

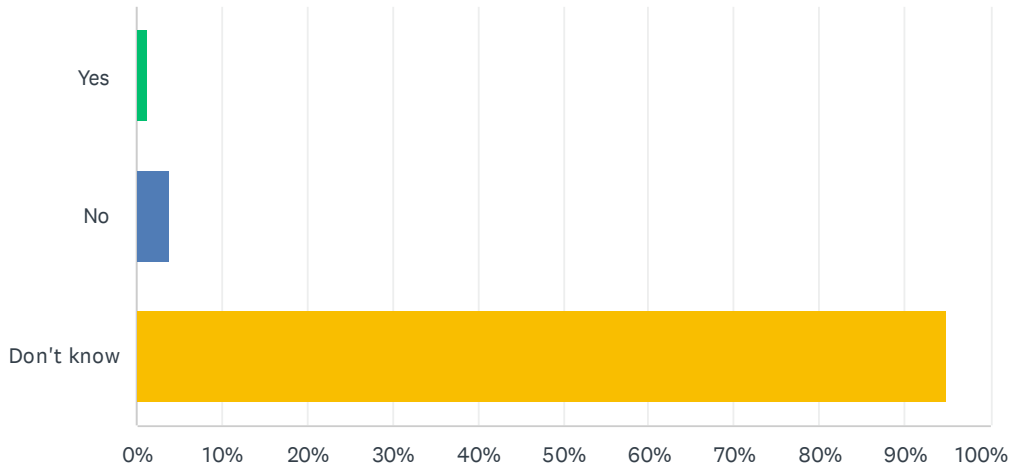

Another voter asked us if we got an answer and I told her no, so she got out of the car and got in line. Also, there were three men that sat right outside the entrance (within the 75 ft electioneering perimeter) at a table in the shade working on laptops. They ended up closing down the location (which I reported).

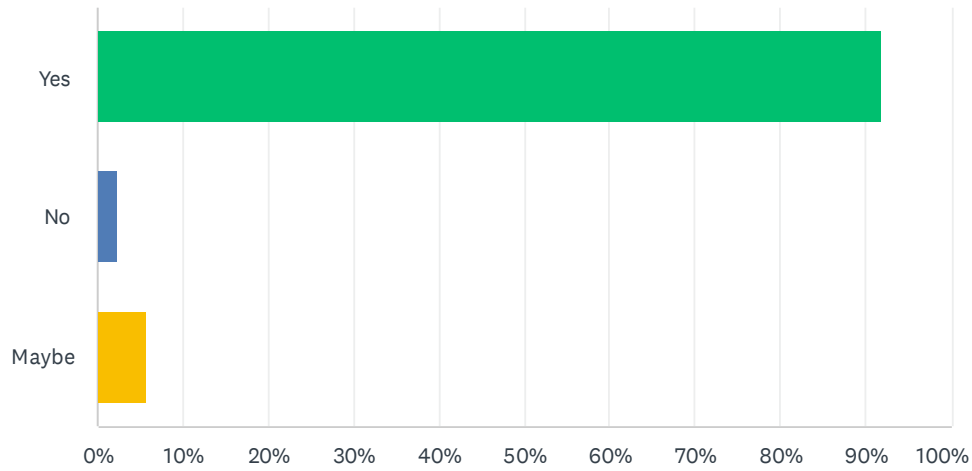

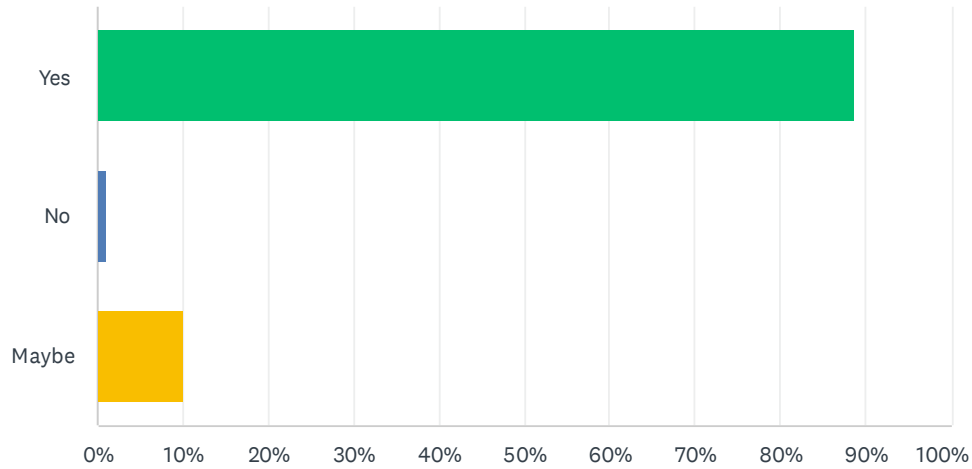

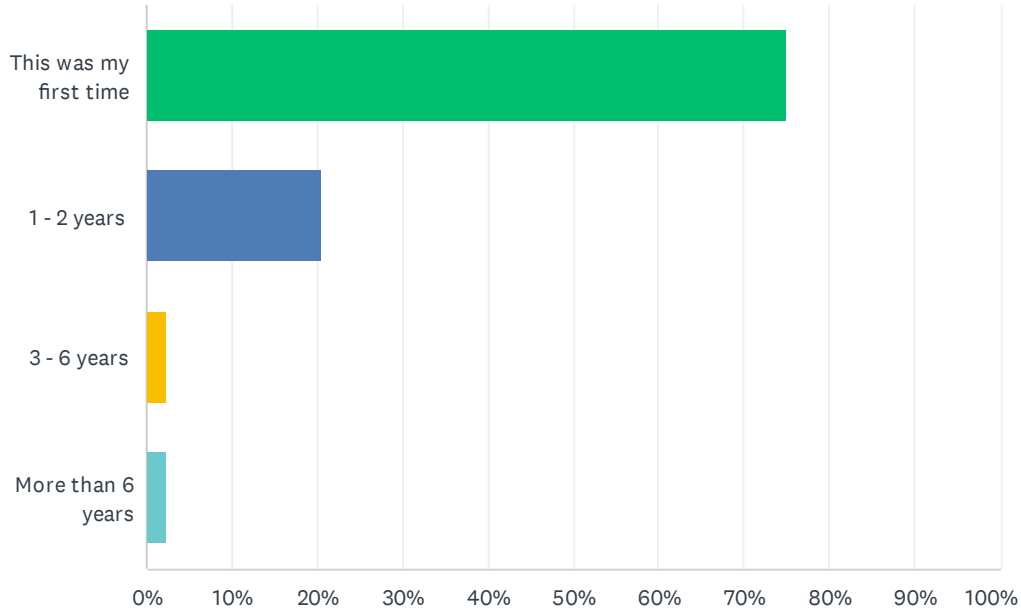
